# **SIRN 2020 January Status Update**





### Phase 1 / Group 5 Locations (State Radio and State Radio Back up)

- State Radio Back Up (Scope changed to add additional consoles to the Cen-Comm location)
  - Deployable Laptop Configuration / testing- Item postponed until the operational requirements are defined by DES / State Radio and NDITD
- State Radio (Postponed until Statewide Coverage is completed)
  - Network Equipment has been installed at the location
- New System Consoles adds for the following have been proposed- National Guard (console only) & Health Services (full dispatch)

#### **SIRN 2020 Contract Extension**

- (1) Year extension and (3) contract renewals have been completed
  - New Contract date in now January 2028
    - Contract pricing is held along with Equipment discounts

### VPN Core setup / Configurations / Testing

- ND and MSI Overall Architecture -
  - Overall Network drawings have been updated with possible future options added
    - State teams are working on Cyber security risk Assessment, MSI to support as required
  - DSR (Fargo Core) testing procedure sent to team for review
    - ATP acceptance of NICE logging- Complete
    - Radio Management (RM)- ATP complete
      - Teams to start working on retouch schedule while the State AG is reviewing RM access needs
    - Smart Connect- ATP has been completed

# **SIRN 2020 January Status Update**





- Overall Site Build Status for Locations in which an NTP Has Been Received (126 Contract Locations + One Change Order)
  - (82) locations have been completed (30 Locations are in Use for Simulcast with ASR support, 52 other locations complete)
  - In Process- Sites with Partial Civil Construction complete-
    - A&E Started , Site in Permitting Process, Sites with Partial Construction
  - Open- Sites requiring lease OR MOU / State Decisions needed / Alternate Locations needed
- Overall Site Build Status

- RF Site Optimizations / Acceptance Test Plan (ATP) for Q1
  - (4) Locations Planned to be ATP'ed
- RF Site Civil Work for Q1-
  - Targeting (2) shelter deliveries
  - (4) RF Equipment installed are targeted
  - (3) Antenna and Mount Installs planned (Lines will be installed in the Spring)

# **SIRN Build Out: NEXT STEPS**





## Overall Phase Two Schedule(2024 Civil Work)

- Planned Civil Work (Locations that are clear to start Construction)
  - Q1-(2), Q2-(11), Q3-(1) and Q4-(0)
- Sites requiring A&E work to be completed (Pending final leasing, MOU, TERO / Permitting)
  - Q1-(0), Q2-(6), Q3-(6) and Q4-(1)
- Work with State team to help obtain additional site locations / leasing to keep the civil construction teams active for the full build season.
- Awaiting State NTP (Group 6=13 ) to start this group.

#### **System Training**

- MSI is working with Training team to develop custom 2 week Training course
  - Targeting Late Apr / Early May to have trainers in market

### Network Design

- Radio Mangemant / Radio Re-Touch schedule will be provided once complete
  - Need State AG to determine who will get RM access
  - Radio Encription may be rolled into the re-touch plan (Pending State decesion)
